



## Court Convicts Three, Acquitts Photographer

Three persons were convicted in Plymouth yesterday of contempt of court for their participation in the seizure of Parkhurst Hall on May 6. A fourth defendant, David L. White '71, was acquitted.

Grafton County Superior Court Judge Martin F. Loughlin sentenced Frank H. Reynolds '69, Timothy Breen '71, and Ronald Grace of Sunapee, N. H., to 30 days in jail and fined them \$100 each. The sentences are identical to those given 45 other persons jailed for the same offense.

Grafton County Attorney N. George Papademas said last night he requested that sentence to insure "equal justice" for all persons found guilty.

White was acquitted after he testified that he was taking movies of the occupation for a class film. J. Blair Watson, Jr., director of College Films, testified in White's behalf. A number of students and faculty members also testified at the proceedings.

White told the court he ran out of film and later re-entered the building without his camera. He said he was unaware of what the injunction said.

The three convicted persons and White were defended by attorneys Francis Eades of Woodsville and William Kennedy of Keene. Kennedy said he did not plan to appeal the convictions.

ion by the U.S. First Court of Appeals on a writ of habeas corpus for the 45 persons now in jail "at any time." Rosenberg has filed a writ of certiorari with the U.S. Supreme Court for 40 persons denied bail by the Court of Appeals. He said Chief Justice Earl Warren, who is in charge of the First Judicial Circuit, would decide the matter.

"We have several things going in tandem," Rosenberg stated. He emphasized that the bail question must be resolved before the 30-day sentences expire "to keep the case alive on merits."

Rosenberg noted that "no court would take a dead case," and expressed concern that the cases of the 45 arrested persons would be dropped if those in jail are not released before the end of their sentences. Five individuals who claimed they were not

in the building were granted bail last Friday by the U.S. Court of Appeals in Boston.

Assistant Dean of the College Paul Rahmeier said the College Committee on Standing and Conduct has prepared a letter to be sent to all *joined* students along with a statement from Dean of the College Thaddeus Seymour.

Rahmeier, a temporary member of the CCSC, said he assumed "each student will be left to work out whatever he can with his professors." He said books and study materials have been received by the jailed students.

The three persons convicted yesterday have been jailed in Woodsville. The remaining five defendants will face charges at a later date. Another judge has not yet been named to hear their cases.
